- Peace and conflict resolution, Disease prevention, water and sanitation, clean water and hygiene, basic education and literacy are just some of the areas of focus for Rotary Foundation.
- Donations are tax deductible
- 13 out of our 21 members have a Paul Harris
- 1000\$ US donation for a Paul Harris
- Our club has contributed almost \$55,000 since 2004
- This year so far our budget is \$2100, based on \$100 per member.
